
## A Statement From Gov. Edwards on The Death of George Floyd:

"Although I never knew George Floyd, I will never forget him or the fact that his death was both terribly wrong and completely and easily avoidable. No one who sees the video of his death can deny this, which is why it is important for all of us, regardless of the color of our skin, or ethnicity, to speak out against this great injustice. For too long, we have failed to fully address the lasting and insidious impacts that racism and racial inequality have had on our society. No one should fear violence or mistreatment because of the color of their skin. I share the outrage and my heart hurts along with everyone impacted by what is happening, but especially our African American brothers and sisters who throughout this difficult and heartbreaking week have had to again call into question their hope for justice and equality. Unfortunately, this hits home for Louisiana and many other communities across the country. As Dr. Martin Luther King has taught us, injustice anywhere is a threat to justice everywhere. Creating a better world for our children and grandchildren begins with each of us reflecting on the biases we hold, sometimes unconsciously, and how we can treat each other better. Hope deferred

Masked vandals smashed windows, slashed police car tires and threw bricks in a standoff that lasted until 5:00 a.m. The Minneapolis Police Department fired four police officers who arrested Floyd. The 46-year-old died after an officer pinned him down by the neck with one knee.

MINNEAPOLIS — Protests turned violent on Tuesday as anti-police activists smashed windows and vandalized police cars in response to the death of an African American man at the hands of four law enforcement officers.

George Floyd died Monday after his arrest outside Cup Foods, a Minneapolis restaurant that reported a customer who paid for a meal with a counterfeit \$20 bill. Widely circulated videos of the incident show a handcuffed Floyd on the ground with a white officer's knee on the back of his neck, his pleas for help ignored.

"I can't breathe," Floyd told the officer. The 46-yearold man died later at the Hennepin County Medical Center.

Thousands of protesters descended on a police precinct a day later. Some spray-painted patrol cars, slashed tires and broke windows.

Police responded with tear gas canisters after the crowd broke through the gate that protected more vehicles. The standoff lasted until 5:00 a.m., with demonstrators hurl-

ing bricks and other objects at police.

Protesters had walked more than 2 miles from Cup Foods, organized by activists who would later try to keep the march peaceful.

Minneapolis Police Chief Medaria Arradondo fired Officer Derek Chauvin and three other officers who were pres-

This officer failed in the most basic human sense," Minneapolis Mayor Jacob Frey said in a press conference.



## **Gov. Edwards Orders Flags at Half-Staff** in Honor of Trooper George Baker

BATON ROUGE - Gov. John Bel Edwards ordered flags to be flown at half-staff over the State Capitol and all public buildings until sunset on Thursday, May 28, 2020, as an expression of respect for Louisiana State Police Trooper George Baker who died from injuries sustained in the line of duty. Trooper Baker is survived by his wife Heather, daughter Harper, his parents, sisters, and extended family.

Trooper Baker served in the United States Marine Corps for eight years, deploying on a combat tour in the Middle East, before serving with the Greensburg Police Department, St. Helena Parish Sheriff's Office and the

Louisiana State Police.

"As a United States Marine, Greensburg Police Officer, St. Helena Parish Sheriff's Deputy and Louisiana State Police Officer, Trooper Baker dedicated his life to serving and protecting others. Even after his passing, Trooper Baker continued to help those in need by donating his organs," Gov. Edwards said. "He lived the Louisiana State Police values of courtesy, loyalty, and service every day, and his integrity and bravery will long be remembered. I ask the people of Louisiana to continue to lift up Trooper Baker, his family, friends, and colleagues in prayer as we all mourn this great loss."

## **EBRP Library To Enter Phase 2** of Re-Opening Plan June 1

The East Baton Rouge Parish Library will move into Phase 2 of its phased re-opening process starting Monday, June 1. "Although we were pleased to offer digital services over the past weeks, and then to expand access on May 20 with call ahead/ pickup services and more extensive phone and online reference help, we are now ready to increase access by opening significant portions of the public service spaces in our buildings. We have successfully completed our first phase of preparations, which included reconfiguring furnishings, establishing appropriate social distancing provisions, and accepting and quarantining a large influx of returned library items. We also have secured sufficient special supplies and materials to help maintain an elevated level of preventive intervention. As the details of this phase of our reopening explain below, there are some changes and new procedures that will be necessary with the use of library public spaces. We appreciate that this will require a certain level of adjustment, but we hope that everyone can work with us to make their library experience as safe and rewarding as possible", said Library Director Spencer Watts.

In Phase 2 of the Library's Re-opening Plan, the following services will be available to our

- Libraries open doors to the public to provide use of PCs, Wi-Fi, and fresh checkouts of material
- Library locations will open to the public from 9 a.m. until 8 p.m. Monday through Thursday; 9 a.m. through 6 p.m. Friday and Saturday; and 2 p.m. through 6 p.m. on Sunday.
- The new River Center Branch will open later in June; its opening date has been pushed back due to delays in furniture and equipment installation.

• Telephone assistance is available as usual at all 14 locations during these hours.

As required by City-Parish, all patrons entering Library buildings must wear a face mask or other personal protective equipment (PPE)

Because of the need to increase distance between workstations, a reduced number of Public PCs will be available on a "reservations" basis:

- Please call the Reference sk at your desired location to make a reservation
- Reservations for slots during the first hour the Library is opened may be placed the day
- Headphones will not be available; please bring your own • Keyboard and mice will be
- cleaned after each use
- Public PCs will be available until 15 minutes before closing
- Printing, copying and faxing will be available
- Computers and Wi-Fi are temporarily unavailable at the Delmont Gardens Branch due to connectivity issues

Wi-Fi will be available inside and outside from 8 a.m. until 8 p.m. at all 14 locations

Seating will be limited; physical distance will be maintained between seating, tables and computers

Protective Measures:



Acrylic sneeze guards will be placed at service desks and visual reminders related to social distancing will be in use at each location

Hand sanitizer will be available at each location

PPE will be in use by staff at each location; masks are man-

Expanded cleaning protocols and an accelerated schedule for disinfecting and deep cleaning at each location

The Library collection will be considered "Closed Stacks" during this time period; this protective measure will help prevent exposure to the virus

Patrons may call ahead to locate materials, or reserve items

Patrons who come in person will need to request materials directly from Library staff. Library staff will then search the shelves for desired books or AV materials and bring them directly to patrons to minimize contact

Patrons will be able to check out their materials via Self Check Kiosks at all locations or receive assistance at Circulation Services

Call Ahead/ Drive Through/ Pick Up Service will continue at all locations, so that patrons who want to minimize contact may Library materials may be

returned to any location; items that are trapped to fulfill Reservations will be quarantined for 72 hours before becoming available to the patron who is "on Hold"

We encourage reserving the first hour of service for seniors and those with compromised immune systems; please consider arriving at or after 10 a.m. if you are not in that category

Children under the age of 12 must be accompanied by an adult or care-taker

We will monitor occupancy of the library and as necessary, limit the number of patrons who may be inside at any given time; occupancy limits will need to be strictly enforced

We will not accept money other than through the usual online credit card service

## **Graves Announces Major Comite Diversion Canal Construction Project**

WASHINGTON, DC – U.S. Congressman Garret Graves (South Louisiana) announced today that The Corps of Engineers has awarded the first Comite Diversion Canal construction contract in 15 years. The \$55,050,170 contract will include the construction of two new bridges, US 61 bridge and Kansas City Southern railroad bridge, and excavation and construction of the canal from US

"This is the moment residents of East Baton Rouge, Livingston and Ascension Parishes have been waiting and paying for decades to happen. We are taking our first major step toward the completion of the Comite Diver-

sion project. Under the current construction schedule, we will have better flood protection by the end of next year," Graves

During the Bipartisan Budget Act of 2018 (BBA 2018), Graves was serving as the chairman in charge of the Corps of Engineers at the time and was able to break a decades-old logjam and secure a record \$1,400,000,000 (\$1.4 billion) on three key flood control and hurricane protection projects for South Louisiana. Graves also secured \$300 million through the FEMA Hazard Mitigation Grant Program and \$50 million in USDA funding specifically for Livingston Parish flood mitigation – made possible due to a Graves' amendment in

the February 2018 federal fund-

'We've been able to secure \$3 billion in flood protection funding since the 2016 flood. The \$1.4 billion is paying for the 1980s protection on projects like Comite that should have been built decades ago. The \$1.2 billion and other additional funds are future protection, which will allow the Capital Region to be better prepared and more resilient for the natural events we expect to happen," Graves said.31, 2021, which is the target completion date for the entire Comite River Diversion Canal.

State sales tax returns are due on the 20th day of the month following the applicable tax period.

LDR will waive penalties for state sales tax filers who submit their March 2020 and April 2020 returns, and remit the sales tax and any interest owed, by June 30, 2020. If a taxpayer cannot remit the sales tax and interest by June 30, they will still be eligible for penalty relief if they enter into a payment installment agreement by June 30.

## **BREC Announces Registration for Online and In-Person Summer Camps**



BATON ROUGE, La. - This summer BREC will offer a variety of activities, experiences and camps to serve as many children as possible while following state and federal recommendations to ensure the safety of campers and camp staff. BREC will offer virtual-only camps from June 1-5, and both in-person summer camps and virtual experiences from June 8-July 31.

Registration will open Friday, May 22 at 9 a.m. for the first week of virtual camp. For weeks two through four, registration for virtual and in-person camps will open Tuesday, May 26 at 9 a.m. Available opportunities and registration details for the month of July are expected to be announced sometime in June as additional information becomes available from public health officials. BREC will host in-person camps and continue virtual experiences throughout the month of June. BREC's virtual camps will involve interactive streaming experiences with "Camp in a Bag" supplies that participants can retrieve at six different BREC park locations to provide accessibility across the parish. All of BREC camps are inclusive and welcome children of all abilities.

To meet the needs of our parish, BREC's recreation professionals consulted with peers across the nation, the CDC, state health officials and the American Camp Association to make informed, strategic decisions to create camps that balance safety while providing campers with fun, engaging experiences. In accordance with those recommendations, capacity will be limited with a ratio of nine children to one adult. BREC staff will conduct temperature checks, frequently sanitize supphysical distancing, rotate camp experiences among small groups and wear masks while working with children and their parents.

"As the local economy continues to reopen, summer camps and summer experiences are more important than ever to allow parents to get back to work, and while the experience will be different, this year BREC will be even more accessible across


the parish with a combination of online and in-person experiences," said BREC Superintendent Corey Wilson. "We have carefully considered every aspect of these experiences down to the number of children that will be allowed to sit at a table, how to provide art experiences without anyone sharing materials, exciting guests who bring new experiences to campers to replace the traditional field trips as well as the creation of online experiences that are interactive and challenging for all ages. "Our top priority throughout the process has been to ensure the safety of the children and our staff, and we are prepared to adjust and adapt as necessary to ensure everyone's safety while also providing enjoyable experiences," said Wilson.

Parents or guardians must register online at webtrac.brec. org for all online and in-person locations this summer and may register for more than one camp or activity during a day. Each offering will vary in duration. Registration for individual camps will close the Thursday prior to the beginning of each session or once a session is full. From recreation and theatre to animals and science, there is a camp for children of all abilities and interests. Summer camp dates, times, ages and fees vary per camp.

BREC will offer virtual experiences through Independence Park Theatre, Magnolia Mound and Highland Road Park Observatory through week one and offer virtual experiences through Community Recreation, Conservation and BREC Art throughout the summer.

BREC will also offer traditional camps in general recreation at eight locations as well as special interest summer camps at the Bluebonnet Swamp Nature Center, Farr Park Equestrian Center, Highland Road Park Observatory and Magnolia Mound. Due to a lack of outdoor classroom space and recommendations for social distancing, the Baton Rouge Zoo will not be able to hold summer camp this year.

# Mayor Broome Announces Expanded COVID-19 Testing in EBR Parish



BATON ROUGE, La. — Mayor-President Sharon Weston Broome announced Thursday the expansion of COVID-19 community testing sites throughout East Baton Rouge Parish. The expansion will offer mobile testing at various sites, Monday through Friday, for the month of June. The initiative is a partnership with Ochsner Baton Rouge, Our Lady of the Lake Medical Center, East Baton Rouge Parish School System, BREC, and a number of area Federally Qualified Health Centers (FQHC), including: CareSouth Medical and Dental, Open Health Care Clinic, RKM, and Southeast Community Health Systems.

"As our community has now entered Phase One of reopening, receiving a COVID-19 nasal swab test is one the most important steps our residents should take to protect their health and the health of their loved ones," said Mayor Broome. "These testing sites do not require a doctor's order and are offered at no out-of-pocket cost to the patient. Everyone who believes they need a test, should take advantage of this valuable resource."

The mobile testing sites are in addition to about two dozen fixed testing sites in East Baton Rouge Parish. A list of mobile testing sites and fixed testing sites can be found here.

## Restaurants in America Hard Hit by COVID-19 **Face Uphill Battle to Return to Normal**

"There's a lot of fear, will tourists come back, will people come out? Are the employees going to want to come back to work? How are we going to convince everybody it's safe and healthy to eat in a restaurant again?"


This is what Melissa Fleischut. president of the New York State Restaurant Association, told a reporter last month.

The devastating economic impact of the coronavirus pandemic has been particularly divesting to the restaurant and service industry. One estimate proclaimed that 40 percent of restaurants in New York are unlikely to reopen after the pandemic is over. But even after it ends, there is fear that business won't be the same until some months after cities officially

Over 660,000 people employed in restaurants in New York state alone have been furloughed. They are part of the over 30 million people in the U.S. who have likely filed for unemployment since the middle of March.

According to reservation app OpenTable, reservations in Seattle were down 31 percent by March 3 right as the coronavirus was reported to have caused a fatality in the city. San Francisco saw a 24 percent decline. Soon after the drop was close to 50 percent.

Social distancing rules are a huge challenge to the restaurant industry in a way that is likely to impact revenue for some time to come. Though Georgia Governor

Brian Kemp re-opened much of the state last week, over 120 restaurants in Atlanta are refusing to open their dining rooms until they believe it's safe.

Prominent Georgia chefs have formed the "#GAHospitalityTogether" initiative. The group includes award-winning chefs Ford Fry, Anne Quatrano, Hugh Acheson and Mashama Bailey.

Late on May 1st it was learned that 1,165 Georgians have died due to the outbreak. In the past 24 hours (as of this writing), the Georgia Department of Public Health has recorded 33 COVID-19 deaths for a total of 26,000 infected.

For African American businesses that are cash strapped the challenge is even tougher. A majority of Black-owned businesses have only one employee and many are contractors. Many elected of-

ficials and civil rights groups are focused on Black owned businesses during the COVID-19 pandemic.

"Our Lady of the Lake is proud play a part in expanding access to COVID-19 testing by deploying mobile testing sites throughout our community. Increased testing is essential to managing COVID-19

and preventing a spike in cases," said Coletta Barrett, VP of Mission, Our Lady of the Lake.

Also, patients using the Mayor's Office of Homeland Security and Emergency Preparedness (MOHSEP) Community Testing Site at Baton Rouge General Mid City, will now be directed to the recently opened CareSouth testing site on Florida Boulevard, less than a half-mile away. Thus, the MOHSEP Community Testing Site at Mid City will begin to phase out over the next three weeks. Early on in the pandemic, a coalition of hospitals and clinics partnered with MOHSEP to stand up the Mid City site, taking the strain off area clinics and health centers.

Beginning Monday June 1st, the second MOHSEP Community Testing Site outside OLOL North Campus on Airline Highway will transition to testing inside the clinic.

Since March 16, 2,391 people have been tested at the MOHSEP sites. The initiative relied on local resources without aid from the state and federal government. Partners in the initiative include the Baton Rouge Clinic, Baton Rouge General, Ochsner Baton Rouge, Our Lady of the Lake Medical Center, and Woman's Hospital.





## America's Moms Grieve George Floyd, Demand Accountability and Justice for His Murder

Statement of Kristin Rowe-Finkbeiner, executive director and CEO of MomsRising, an online and on-the-ground organization of more than one million mothers and their families, on the brutal murder of George Floyd by Minneapolis police:

"The moms of America are gutted that George Floyd was killed by four police officers earlier this week. No mother should have to worry about the loss of a loved one at the hands of those charged with protection. No one should lose their lives.

"MomsRising is calling for the police officers who killed George Floyd to be charged with murder and for the vicious and inflammatory attacks on protesters, including the inflammatory attacks by President Trump, to stop immediately.

"We grieve, we're angry, and we will not stop holding leaders accountable: This includes prosecutors, who hold more power in the criminal justice system than almost anyone else. It includes everyone from mayors and governors to the president of the United States.

"Sadly, it's not just George Floyd. It's Breona Taylor. It's Ahmaud Arbery and Atatiana Jefferson. It's a list of names too long to fit on this page. Each of whom was a person, with loved ones, dreams, and lives to be lived.

"It's a president who has encouraged police violence and is consistently and openly fueling white supremacy in our nation. A president who just last night Tweeted an implication that protesters could be shot, implying that he'd order the military to act as judge, jury, and executioner, using wording that has historically stoked anti-Black racism. A tweet so racist and incendiary that Twitter took the rare step of putting a warning label on it for "glorifying violence" and limited the public's interaction with it. And it's this same president who has also dog-whistled white supremacists, militias, and vigilantes time and again.

"It's a system that directly targets Black people and people of color through sanctioned acts of violence; and structurally targets people of color by intentionally cutting programs, diverting resources, and so much more.


"It's police brutality, it's an unjust criminal justice system, it's the wage gap that dispropotionatly harms moms of color the most, it's discrimination in the health care system that's leading to more people of color losing their lives to COVID-19 and to Black women dying three to four times as often as white women while giving birth. It's Amy Cooper, a white woman who called the police saying, 'I'm going to tell them there's an African American man threatening my life.'

"It's white supremist groups with guns marching on state capitols protesting public health measures that scientists have prescribed to stop the pandemic -- and remaining unharmed and untouched by law enforcement; while protestors of color demanding an end to police brutality are met by tear gas and rubber bullets.

"All of this is why the moms of America demand full accountability for what happened to George Floyd. And why we will never give up demanding a system and a country in which everyone can live and thrive."


